Course:

Challenging 40K out and back course starting just south of town

40K course - Southwest on Angling Rd, West on N 46th Rd, North on E 3rd Rd, and back.

20K course - Southwest on Angling Rd to N 46th Rd and back.

Juniors ride 20K, all other categories ride 40K

Starting order – 9:01AM start, one-minute intervals, based on order of registration.

Awards:

Medals – awarded five (5) deep in all categories

Overall Fastest Males and Females – Fastest times for the day cash awards (\$50 / \$40 / \$30 / \$20 / \$10)

One cash award per rider. Recumbent and Tandem not eligible.

Profile for Speed – Rider entry raffle for merchandise (Profile Aero Bars)

MATTS – points awarded towards 2009 MATTS points series and \$5000 in overall Season prizes

ROTY – points awarded towards Wisconsin / Illinois Association Rider of the Year

Registration:

Entry Fee – \$20 pre-registered / \$25 race day Juniors Entry Fee – \$10 pre-registered /\$15 race day

ABR membership – required, one day \$5, annual \$25, junior annual \$10

Racers who choose to compete in more than one category may race a second time for an additional \$10
